LBWID Operations Director's Update

- Dam Hydraulic Pump and Electric Motor Replacement update –purchased two new pumps and the old pumps will be reconditioned and put in spare inventory. Also one motor was rebuilt for the spare inventory.
- New Push-boat update boat has been delivered.
- o Dam concrete joint seal repair update.
- Dam catwalk access ladder repair update is done with 4 new rungs.
- o Dam cathodic protection system anode replacement update.
 - Installation will be in May or June of this year requires diving, so waiting for warmer weather.
- o Bouy line/boat barrier anchor chain/cable inspection.
 - Preliminary inspection by camera.
 - Physical inspection once the Lake water warms up. Updated a couple years ago.
- Inspection of Bascule gate position sensors
 - Scheduled for May may need to be replaced, as they are 3-4 years old (they usually last 5-6 years). About \$1500 each.
- o Replacement of the Dam's hydraulic cylinder hydraulic hoses
 - Scheduled for June or July. Do have a spare set, about \$5000, and last about 5 years.
- o Lake clean-up, removal of storm debris from the winter months ongoing.
- o LBWID's spring production dredging season (Tripps Run side of the Lake/Beach 5)
 - Started April 8th and will take 4 to 6 weeks to complete.
- Assistance with LBA's spring activities
 - Pre-clean of all beaches
 - Official beach clean-up is scheduled for May 8.
 - Spreading of new beach sand, the week of May 15.
 - Launching LBA lifeguard boats, May 17.
 - Reid Voss's (LBA Maintenance Chair) request for assistance with LBA projects attached letter of request. Discussed, and will help how we can with appropriate activities.

LBWID Financial Update

- o FY-2024 July March Income/Expense Statement.
- o FY-2025 Budget
 - Approved by NVS&WCD on February 27^{th.}
 - Virginia Soil & Water Conservation Board voted on March 27th.
 - Have not yet received official notification of approval.
- Charles Schwab to Truist Bank transition update decided to keep open with minimal amount of funds, in case need a second/different account/bank.
 - Investment strategy/plan with Truist Bank all but a few thousand are now transferred to Truist.

East and West Dam Embankment Armoring Project

o LBWID Virtual Information Session #5 (May 8th @ 7pm) (virtual via Zoom) − an overview of the project to date; no new information but a high level review of the project so far.

- WRA and GKY Update to check with them again on progress.

> LBWID Cyber Security Upgrades

- o LBWID's Sonic Wall firewall/routers (commercial grade) will no longer be supported by its manufacturer as of October 2024.
 - The two existing firewall/routers are approximately 8 years old.
 - One primary and one back-up.
- o At LBWID's request, Applied Controls Engineering (ACE) has submitted a proposal to supply, configure, and install 2 new Sonic Wall firewall/routers.
 - Cost = \$13,310
- Ace also proposed an option for installing Advanced Endpoint Detection and Monitoring software and subscription.
 - One year subscription cost = \$6,200.00. After the initial outlay, it's approximately \$3K per year.
- o All trustees agreed to proceed with ACE's full proposal.
