THE OWNERS OF AT LEAST TWO-THIRDS OF THE LAND AREA VOTED

AT LEAST TWO-THIRDS OF THE LANDOWNERS VOTING VOTED FOR THE ISSUING OF THE BONDS.

THE MAJORITY OF THE REGISTERED VOTERS VOTED FOR ISSUING THE BONDS.
