1. LBWID Financial update

5. 2021 Dam 6-Year Recertification Inspection

- a. All required documents/reports were submitted to DCR Dam Safety on 09/08/2021.
- b. We still not received any response from DCR or Dr. Wang for the letter that we had mailed. Nor has Dr. Wang notified the LBWID that is has changed the LBWID's recertification application. from Regular to Conditional.
- c. DCR has issued a \$300 refund out of the \$600 recertification fee. The fee for the conditional 2-year certification is \$300.
- **6. Fish Stocking** Freys' Fish Ponds, from Gulph Mills, PA, will be delivering the Hybrid Striped Bass the 2nd week of November at a total cost of \$5,000.

7. Dried Dredge Spoil Removal/Trucking

- a. GDC Trucking completed hauling 185 loads of the dried dredge spoils on 10/7/2021.
- b. Total cost of the project was \$53,000. We had budgeted \$115,000 for dredge spoil disposal in FY-2022.

8. First Christian Church & Dar al Sahlam Projects

- a. Mason District SSPA meeting took place Wednesday, October 28th at 7:00pm (Virtual) and focused on land use applications.
- **9. Filling the LBWID staff position in vacated in October of 2020.** Emmett Suarez has been selected to fill the vacant LBWID position. Emmitt has worked for Washington Metropolitan Area Transit Authority (METRO) for 10 years and brings an array of construction/maintenance-based skill sets to the LBWID.
- **10. Potterton Drive sanitary sewer pumpstation landscape plan. -** Fairfax County has agreed to plant Emerald Green Arborvitae between the pumpstation and Potterton Drive to establish a vegetative screening of the pumpstation. They will be planting 6' to 8' foot tall trees and will be planting them approximately 4 to 5 feet apart.
