1. LBWID Financial Update

- a. FY-2022 Income/Expense Report July May No unforeseen variances. See Attachment 1.
- b. The impact of the upcoming cost of living increases in staff pay are unlikely to have an impact on the overall budget. If the increases are greater than expected the reserves will be tapped to offset the need to increase annual property taxes.

2. VRSA Insurance Renewal for FY-2023

- a. There will be a \$231increase the annual premium, which increases from \$28,422 to \$28,653 per year for FY-2023.
- b. Davis has made an inquiry about increasing liability coverage above \$5 million. He is waiting for a reply. The Trustees recommended that no change be made to our liability coverage at this time.
- **3. Dam Embankment Analysis DCR Dam Safety** The Trustees reviewed and accepted the WR&A proposal for phases 1 and 2 of the embankment analysis. A total expenditure of \$127,752.75 was authorized. See Attachments 2 6.
- 4. Upgrading Dam's Primary and Back-up HMI The Trustees reviewed and accepted the Applied Controls Engineering (ACE) proposal for upgrading the dam's computer control system. A total expenditure of \$27,600 was authorized. See Attachment 7.
- **5.** Dam Hydraulic System Maintenance and Inspection Advance Fluid Systems is currently performing routine maintenance on the dam's the hydraulic control system including:
 - 4-way valve replacement
 - Accumulator repair
 - Accumulator gauges
 - Hydraulic pump/electric motor coupler replacement
 - Hydraulic oil sample testing
